



RULES OF OUR STABLES ARE BASED ON COMMON SENSE. THEY ARE IN PLACE TO ENSURE THE HEALTH AND SAFETY OF THE HORSES, THEIR OWNERS AND GUESTS.

STABLE RULES

- 1. KEEP AISLES AND WASH AREAS FREE OF GROOMING TOOLS, TACK AND OTHER EQUIPMENT.**
- 2. CLEAN UP ANY DEBRIS AFTER GROOMING. COVER URINE SPOTS WITH SAWDUST. RAKE UP MANURE PILES (OUTSIDE THE STALLS) AND DEPOSIT IN A MUCK BUCKET OR THE MANURE SPREADER.**
- 3. NO LITTERING. USE PROPER TRASH CONTAINERS PROVIDED.**
- 4. TURN THE WATER OFF AT THE FAUCET AND COIL THE HOSE AFTER USE. ONLY USE THE CITY WATER (SIGNPOSTED) IN EMERGENCIES.**
- 5. KEEP A CAREFUL EYE ON YOUR HORSE WHILE IN CROSS-TIES OR IN ANY AREA OTHER THAN STALLS, PASTURES OR ARENAS.**
- 6. PUT IT AWAY ANY EQUIPMENT WHEN FINISHED IN THE ARENAS.**
- 7. TURN OFF LIGHTS IN ANY OF THE STABLES AND INDOOR ARENA WHEN FINISHED.**
- 8. KEEP ENTRANCE AND PADDOCK GATES SECURED AT ALL TIMES. CLOSE AND SECURE THE GATE TO THE TRAILS FOLLOWING YOUR RIDE.**
- 9. DO NOT USE SHAVINGS FROM THE STABLE'S STOCKPILE. IF YOU WANT ADDITIONAL SHAVINGS YOU CAN PURCHASE BAGS OF SHAVINGS OR PELLETS (NO BLACK WALNUT) AT A STORE.**
- 10. STORE SPECIAL AND SUPPLEMENTAL FEEDS IN MARKED RODENT-PROOF CONTAINERS IN THE FEED ROOM. WRITE THE HORSE NAME ON ALL OTHER CONTAINERS OR BAGS.**
- 11. NOTIFY THE STABLE OWNER OR MANAGER OF ANY NEEDED MAINTENANCE AND REPAIRS, OTHER FACILITY PROBLEMS OR SUPPLY SHORTAGES.**

12. DO NOT MODIFY OR UPGRADE STABLE AND STALL EQUIPMENT [FEEDERS, WATER BUCKETS, GATE CHAINS ETC.] WITHOUT PRIOR APPROVAL FROM THE OWNER OR STABLE MANAGER.
13. DO NOT USE EQUIPMENT OR TACK BELONGING TO THE STABLES OR ANOTHER BOARDER WITHOUT PRIOR PERMISSION. IF YOU DAMAGE EQUIPMENT OR TACK DURING UNAUTHORIZED USE, YOU ARE RESPONSIBLE FOR REPAIRING OR REPLACING THE ITEMS.
14. STEALING AND CAUSING DAMAGE TO STABLE PROPERTY WILL NOT BE TOLERATED AND WILL RESULT IN IMMEDIATE REMOVAL FROM THE PROPERTY.
15. ONLY MANAGEMENT [WITH OWNER INPUT] HAS THE AUTHORITY TO ASSIGN HORSES TO PADDOCKS AND STALLS.
16. ABUSIVE TREATMENT [PHYSICAL AND VERBAL] TOWARD HORSES, OTHER ANIMALS, BOARDERS OR GUESTS WILL NOT BE TOLERATED. ANYONE FOUND DOING SO WILL BE REMOVED FROM THE PROPERTY AND MAY BE REPORTED TO THE AUTHORITIES.
17. SMOKING IS NOT PERMITTED IN OR AROUND THE STABLES OR INDOOR ARENA.
18. BOARD RENT AND SERVICE FEES ARE DUE ON THE FIRST DAY OF EACH MONTH. CHECKS SHOULD BE MAILED OR DELIVERED TO (AND MADE PAYABLE TO) CROSS TRAILS STABLES
19. DOGS ARE ONLY ALLOWED ON THE PROPERTY IF THEY CAN DEMONSTRATE RESPECT AND SELF-CONTROL AROUND OTHER ANIMALS, PEOPLE AND PROPERTY.
20. NOTIFY THE STABLE OWNER IF YOU ARE GOING TO BE ARRIVING AND/OR DEPARTING BETWEEN THE HOURS OF 9:00 PM and 8:00 AM.
21. DO NOT USE OR RIDE ANOTHER'S HORSE WITHOUT PERMISSION AND A SIGNED CONTRACT.
22. HORSES WILL ONLY BE EXERCISED, WORKED AND LUNGED IN THE INDOOR AND OUTDOOR ARENAS OR THE ROUND PEN.
23. USE A SUITABLE HALTER AND LEAD ROPE WHEN LEADING A HORSE.
24. DO NOT RIDE ANY HORSE IN THE AISLES.
25. OPEN CARRY OF FIREARMS IS NOT PERMITTED. LEAVE YOUR WEAPONS LOCKED IN YOUR VEHICLE.
26. ALL ADULTS MUST SIGN A WAIVER PRIOR TO RIDING. MINORS MUST HAVE A WAIVER SIGNED BY A PARENT OR GUARDIAN PRIOR TO RIDING.

27. ALL ADULTS SHOULD WEAR CERTIFIED RIDING HELMETS AND ALL MINORS (YOUNGER THAN 18 YEARS OF AGE) MUST WEAR CERTIFIED RIDING HELMETS WHILE ON HORSEBACK.

28. LONG PANTS AND BOOTS SHOULD BE WORN AT ALL TIMES AROUND THE STABLES. FLIP FLOPS AND BARE FEET ARE NOT ACCEPTABLE.

29. YOUNGER CHILDREN MUST HAVE A PARENT OR GUARDIAN ON THE PROPERTY DURING THEIR VISIT. DO NOT LEAVE CHILDREN UNATTENDED NO MATTER HOW HORSE-WISE THEY MAY BE.

30. WHEN RIDING LESSONS ARE IN SESSION, LOOSE, UNATTENDED OR UNCONTROLLABLE HORSES WILL NOT BE PERMITTED IN THE ARENA.

YOU ARE HEREBY ADVISED THAT DIRECT LOSS, DAMAGE OR INJURY TO YOUR HORSE, TACK, EQUIPMENT OR TRAILER IS NOT COVERED BY CROSS TRAILS STABLES INSURANCE WHILE ON THE PREMISES. YOU, AS THE OWNER OF THESE PERSONAL PROPERTY ITEMS HAVE THE FINANCIAL INTEREST IN THE SAME, THEREFORE IT IS UP TO YOU TO BE SURE THAT THEY ARE INSURED UNDER YOUR HOMEOWNER'S, TENANT'S OR OTHER INSURANCE POLICY, OR UNDER A SEPARATE POLICY AS IN THE CASE OF LOSS, INJURY, DAMAGE OR DEATH OF YOUR HORSE.

PLEASE BE CONSIDERATE AND APPLY THE ABOVE RULES AND GUIDELINES TO KEEP OUR STABLES SAFE FOR EVERYONE AND FOR OUR HORSES. THIS NOT ONLY HELPS TO KEEP EVERYTHING IN ORDER, BUT IT SHOWS RESPECT FOR THE OWNERS AND STAFF THAT TAKE CARE OF YOUR HORSES.

THESE ARE YOUR STABLES! IT IS FUN BEING IN A NICE, SAFE AND TIDY PLACE.
